## **Embattled Commissioner and Front Office Respond to Allegations** *New Information Surfaces on Inaugural Hall of Fame Class*

**Colorado Springs, Colo.** – After a quiet start to the year, Shangri La' Wiffleball has been shaken to its core the last two days. On the heels of Wednesday's request for a change of the guard in the SLW Front Office, suspended President Geoff Hixson of the SLWAA fired back. Geoff made outrageous claims in a poorly attended press conference Thursday morning linking the Commissioner to a gambling ring similar to the "Black Socks" scandal of 1908 involving members of the Chicago White Sox major league organization.

Gilliland continued,"I have only recently become familiar with the workings of Shangri La' Wiffleball, but am amazed at the lengths to which certain parties are willing to go to advance their own personal agenda. I have gotten to know Geoff Hixson over the past several months and I have serious doubts regarding his credibility."

"I fully support the raising of the wall and Commissioner Hixson," 2006 League Champion and Hall of Famer Chris Shoemaker stated. This is a devastating blow to the anti-renovation group as Shoemaker, the big hitting lefty, was thought to be opposed to the upgrades. Shoemaker continued, "I won the tournament last year and I can say with a great deal of certainty that a higher wall will in no way impede me from winning again. It's a team sport."

The most shocking news of the day came late in the press conference when Hixson shifted topics. "Jeff Cain has been on a fact finding mission the past week which turned up some very damaging information on two Hall of Famers. I didn't make it public last year, but we began a rigorous drug testing program after the 2004 season. Suspicions were raised when I saw two of our great players had hat sizes close to 10. The President better be careful how far he wants to take these false claims about wiffleball gambling."

Jeff Cain summed up the information yet to be revealed in one word. "Unpardonable," Cain said in disgust.
