## Details of Steroid Investigation Released *Not Yet Time to 'Name Names'*

**Colorado Springs, Colo.** – A sweeping investigation looking into accusations regarding two anonyms SLW Hall of Famers did indeed turn up evidence of heavy steroid use and body enhancing substances. The exact steroid and substances are not officially known at this time, however they are believed to be a muscle enhancer that is strictly regulated by the U.S.D.A. and is to be only for use on game elephants, wild elk and bison. - **5, May, 2006** – 10 and 17 suffer from 'roid rage' as they react to changes to Lake Front Stadium.
